PURPOSE: TO DISCUSS FINANCING OF WATER PROJECT ISSUING GENERAL OBLIGATION BONDS.

The meeting was called to order at 6:35 p.m. with all Councilmembers present.

Larry McKown informed the Council that the interest rate for the bonds would be 3.92%.

Tony French moved to approve the Investment Banking Agreement. Jerry Bruns 2nd, motion carried 4-0.

Thereupon, there was presented an Ordinance entitled:

AN ORDINANCE AUTHORIZING AND PROVIDING FOR THE ISSUANCE OF \$75,000 PRINCIPAL AMOUNT OF GENERAL OBLIGATION BONDS, SERIES 2001, OF THE CITY OF HIGHLAND, KANSAS; PROVIDING FOR THE LEVY AND COLLECTION OF AN ANNUAL TAX FOR THE PURPOSE OF PAYING THE PRINCIPAL AND INTEREST ON SAID BONDS AS THEY BECOME DUE; AUTHORIZING CERTAIN OTHER DOCUMENTS AND ACTIONS IN CONNECTION THEREWITH; AND MAKING CERTAIN COVENANTS WITH RESPECT THERETO. The Mayor declared that a quorum was present and called the meeting to order.

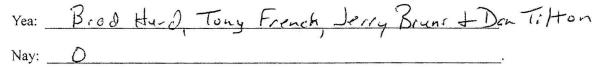
