Mayor Batchelder opened the Public Hearing for the purpose of considering an application to be submitted to the Kansas Department of Commerce for Small Cities Community Development Block Grant funds under the Community Facilities category. A specific project application to be discussed is a street improvement project. Project scope of work will include reconstruction of certain streets and the project will also upgrade certain streets. The estimated project cost is \$1,200,000 with the grant request for \$600,000 of the project cost. Resolution No. 2021-07 is a resolution assuring the Kansas Department of Commerce that funds will be continually provided for the operation and maintenance of improvements to the street system to be financed with community development block grant funds. Motion carried 4-0

Terry Gibson moved and Marty Allen seconded a motion to authorize the mayor to sign: Statement of Assurances, Applicant Disclosure Report, Anti-displacement Plan and Level of Review. Motion carried 4-0

Marty Allen moved and Greg Delzeit seconded a motion to approve the contract for services with Western Consultants DBA Governmental Assistance Services in the amount of \$8,950. Motion carried 4-0

Marty Allen moved and Greg Delzeit seconded a motion to approve the contract for administration service with Western Consultants DBA Governmental Assistance Services, contingent upon grant award. Motion carried 4-0

Terry Gibson moved and Greg Delzeit seconded a motion to approve the minutes of the September 8, 2021, regular city council meeting. Motion carried 4-0

Marty Allen moved and Terry Gibson seconded a motion to purchase insulation (\$700) and tin (\$1,300) for the south half of the shop for \$2,000. Motion carried 4-0 Supt. Lackey is waiting on a bid from MCon and Engemann regarding the installation of the 4" water line to the David Welch's property. Water & Sewer Supt. Saunders asked for approval to attend certification class in Emporia on December 8th, test on December 9th, and explained the need for a state approved meter for Well #3. Marty Allen moved and Greg Delzeit seconded a motion approving Supt. Saunders to attend the KDHE certification class in Emporia on December 8th and take the Class II examination (\$25) on December 9th with the city paying the fees, room, meals and mileage and, as discussed, purchase an approved water meter for Well #3, approx. \$2,225, along with making the necessary well house improvements, approx. \$500.
