The loan of \$1,262,000 and grant of \$534,000 will be administered on behalf of the Rural Utilities Service (RUS) by the State and Area staff of USDA Rural Development.

The resolution to adopt authorizes and provides for the incurrence of indebtedness for the purpose of providing a portion of the cost of acquiring, constructing, enlarging, improving, and/or extending the City of Highland's water facility to serve an area lawfully within its jurisdiction. It is necessary for the city to raise a portion of the cost of such undertaking by issuance of its bonds in the principal amount of \$1,262,000 pursuant to the provisions of KSA 15-101et seq and intends to obtain assistance from USDA.
