RESOLUTION # 2021-09

**A RESOLUTION OF THE GOVERNING BODY OF THE CITY OF HIGHLAND,
DONIPHAN COUNTY, KANSAS, DECLARING THE BOUNDARY OF SAID CITY.**

WHEREAS, in accordance with K.S.A. 12-517, the city is to declare, by resolution, its entire boundary, when territory has been added to, or excluded from, the corporate city limits;


WHEREAS, the city passed annexation ordinance #570 on June 9, 2021, adding a five acre tract of land into the corporate city limits;

NOW THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF HIGHLAND, DONIPHAN COUNTY, KANSAS, that the following is a description of the entire boundary of the corporate city limits of said city:

BEGINNING AT THE SOUTHEAST CORNER OF THE SOUTHWEST ONE-QUARTER (SW 1/4) OF SECTION 23, TOWNSHIP 2 SOUTH, RANGE 19 EAST OF THE SIXTH PRINCIPAL MERIDIAN, CITY OF HIGHLAND, DONIPHAN COUNTY, KANSAS, SAID POINT BEING THE TRUE POINT OF BEGINNING; THENCE SOUTH 88°30'13" WEST, 2650.57 FEET ALONG THE SOUTH LINE OF SAID SW 1/4 OF SAID SECTION 23 TO THE NORTHEAST CORNER OF THE NORTHEAST ONE-QUARTER (NE 1/4) OF SECTION 27, TOWNSHIP 2 SOUTH, RANGE 19 EAST; THENCE SOUTH 88°27'58" WEST, 1463.50 FEET ALONG THE NORTH LINE OF SAID NE 1/4, TO THE NORTHEAST CORNER OF FIRST ADDITION TO THE CITY OF HIGHLAND, KANSAS; THENCE SOUTH 3°36'51" EAST, 478.76 FEET; THENCE SOUTH 85°47'20" WEST, 228.80 FEET; THENCE NORTH 43°45'24" WEST, 248.77 FEET; THENCE NORTH 0°49'49" WEST, 215.34 FEET; THENCE SOUTH 88°57'57" WEST, 108.30 FEET; THENCE NORTH 0°54'21" WEST, 88.64 FEET TO A POINT ON THE SOUTH LINE OF THE SOUTHEAST ONE-QUARTER (SE 1/4) OF SECTION 22, TOWNSHIP 2 SOUTH, RANGE 19 EAST; THENCE SOUTH 88°27'58" WEST, 702.55 FEET ALONG THE SOUTH LINE OF SAID SE 1/4 OF SAID SECTION 22 TO THE SOUTHEAST CORNER OF THE SOUTHWEST ONE-QUARTER (SW 1/4) OF SAID SECTION 22; THENCE NORTH 2°01'45" WEST, 982.69 FEET ALONG THE EAST LINE OF SAID SW 1/4 TO THE SOUTHEAST CORNER OF SECOND ADDITION, AN ADDITION TO THE CITY OF HIGHLAND, DONIPHAN COUNTY, KANSAS; THENCE LEAVING SAID EAST LINE OF SAID SW 1/4, SOUTH 88°11'42" WEST, 33.64 FEET; THENCE NORTH 1°48'18" WEST, 922.84 FEET; THENCE SOUTH 88°25'50" WEST, 188.99 FEET; THENCE NORTH 2°01'37" WEST, 77.50 FEET; THENCE SOUTH 88°25'50" WEST, 45.00 FEET; THENCE NORTH 2°01'37" WEST, 52.00 FEET; THENCE SOUTH 88°25'50" WEST, 25.00 FEET; THENCE NORTH 2°01'37" WEST, 187.00 FEET; THENCE SOUTH 88°25'50" WEST, 138.51 FEET; THENCE NORTH 2°01'37" WEST, 314.49 FEET; THENCE NORTH 88°25'50" EAST, 138.51; THENCE NORTH 2°01'37" WEST, 98.51 FEET; THENCE NORTH 88°25'50" EAST, 289.00 FEET; THENCE NORTH 2°01'44" WEST, 16.50 FEET TO THE NORTHWEST CORNER OF SAID SE 1/4 OF SAID SECTION 22; THENCE NORTH 0°13'50" WEST 660.00 FEET ALONG THE WEST LINE OF THE NORTHEAST QUARTER OF SECTION 22, TOWNSHIP 2 SOUTH, RANGE 19 EAST OF THE SIXTH P.M.; THENCE LEAVING SAID WEST LINE, SOUTH 89°46'47" EAST 330.00 FEET ALONG A LINE PARALLEL WITH THE SOUTH LINE OF SAID NORTHEAST QUARTER; THENCE SOUTH 0°13'50" EAST 660.00 FEET ALONG A LINE PARALLEL WITH THE WEST LINE OF SAID NORTHEAST QUARTER TO A POINT ON


THE NORTH LINE OF THE SOUTHEAST QUARTER OF SECTION 23, TOWNSHIP 2 SOUTH, RANGE 19 EAST OF THE SIXTH P.M. THAT IS 330.00 FEET EAST OF THE NW CORNER OF SAID SE QUARTER, THENCE FOLLOWING SAID NORTH LINE OF SAID SOUTHEAST QUARTER, NORTH 88°25'13" EAST 2321.71 FEET TO THE NORTHWEST CORNER OF THE SW 1/4 OF SECTION 23, TOWNSHIP 2 SOUTH, RANGE 19 EAST; THENCE NORTH 88°26'45" EAST 2639.74 FEET ALONG THE NORTH LINE OF SAID SW 1/4 TO THE NORTHEAST CORNER OF SAID SW 1/4 OF SAID SECTION 23; THENCE SOUTH 2°12'17" EAST, 1918.18 FEET; THENCE NORTH 88°19'02" EAST, 461.52 FEET; THENCE SOUTH 2°12'17" EAST, 544.50 FEET; THENCE SOUTH 88°19'02" WEST, 461.52 FEET TO A POINT ON THE EAST LINE OF SAID SW 1/4 TO SAID SECTION 23; THENCE SOUTH 2°12'17" EAST, 193.44 FEET TO THE POINT AND PLACE OF BEGINNING.
